Charter School Reform Needs to Happen Now

Both houses of the General Assembly are due back after their summer recess this month; they need to act in concord to make reform happen. The Senate improved on transparency and accountability issues when it passed House Bill 2, but the House did not agree with the changes before recessing last June. The House needs to concur with the changes or both houses need to appoint a conference committee to iron out their differences. Call your senator and representative to urge their support; you can use the legislative hot line, 1-800-282-0253. Judicial Votes Count: New Statewide Voter Service

A new statewide voter education web site, www.JudicialVotesCount.org, is live as of September 1. It includes profiles of every judicial candidate in the state, along with a variety of information on what Ohio's courts do. Why? Because voters frequently pass up voting on judicial races, feeling that they don't have enough information to make an informed choice. The new site is strictly nonpartisan, and is the product of a partnership of the Supreme Court chief justice, the Bliss Institute of Applied Politics at the University of Akron, which houses the web site, the Ohio State Bar Association, the League of Women Voters of Ohio, the Ohio Newspaper Association, and the Ohio Association of Broadcasters.

Redistricting Reform: Fair Districts = Fair Elections

Supporters of Issue 1, the redistricting reform constitutional amendment that will be on November's ballot, have created a new web site, www.yesforissue1.org. Here you can get the details of the proposal , an explanation of gerrymandering and why it's so damaging, a list of all endorsers to date (including

AAUW), and sign up to volunteer. Because redistricting tends to be an arcane topic, voter education is critical to passage of the amendment. Be sure that you—and your friends and neighbors—are informed of the importance of this amendment.

National Voter Registration Day September 22

AAUW is solidly behind National Voter Registration Day, coming up on September 22, and there are ample resources for getting started on the association web site, www.aauw.org. At the least, please use your Facebook posts and other social media to remind people to register to vote. Anyone needing to update their address can do so on line at the Secretary of State's web site, www.sos.state.oh.us. And if a voter has been inactive for more than four years, that voter could be purged from the poll books and will need to reregister.

Reminder: Two-Minute Activist

Now—the beginning of the program year—is a good time to solicit your branch members to sign up for the two-minute activist. It's the easy way to make sure your voice is heard in Congress on the issues that matter to AAUW members. Dear Diane,

This was an exciting week for AAUW! On Thursday, I testified at a hearing entitled "Preventing and Responding to Sexual Assault on College Campuses" before the House Subcommittee on Higher Education and Workforce Training. It was an honor to be invited and to represent AAUW, and it was satisfying to see the issue taken seriously. Though the opposition and I had varying ideas on solutions for the problem, there was no question that campus sexual assault was definitely a problem that must be addressed. Prevention, in fact, was the common thread of the hearing.

That kind of cooperative, rather than adversarial, atmosphere is what is needed to make progress in creating effective policies for this nationwide problem. AAUW continues to support the HALT act (H.R. 2680) which would require campuses to do climate surveys to get a better handle on the dynamics of sexual harassment and violence in their communities. We also support the SOS Campus Act (H.R. 1490), which would ensure survivors have access to advocates to help them understand their rights and get the support they need.

My participation in this hearing was a team effort and for that I'd like to thank Erin Prangley and Anne Hedgepeth for their expertise and support in preparing me for this challenge. I'd also like to thank all of you who have sent in countless emails and tweets of support before, during, and after the hearing! The AAUW community always rallies when we need you!

would prohibit federal contractors from retaliating against employees who wish to discuss and share information about salaries. This rule serves to implement President Obama's 2014 executive order promoting pay transparency and openness. Federal contracts will now include an equal opportunity clause that prohibits federal contractors from firing or discriminating against employees who discuss compensation. In addition, employees will be made aware of this new transparency because contractors must include a nondiscrimination clause in employee handbooks. The final rule will take effect on January 11, 2016.

White House Launches "Heads Up America" Campaign to Promote Community College Plan

The White House [announced](#) a campaign called "Heads Up America" to promote President Obama's plan to fund two years of free community college for Americans. As the new school year begins, the campaign aims to attract public support for America's College Promise plan, which President Obama proposed in January. He announced the campaign on Wednesday in a speech at Macomb Community College in Michigan. To boost its launch, the speech featured appearances from celebrities such as Chris Rock and Kal Penn. Sexual Assault Initiative Receives \$41 Million in Grant Award

Vice President Joe Biden and Attorney General Loretta Lynch [launched](#) grants to address the backlog of rape kits in 27 states. In conjunction with the New York County District Attorney's Office grant of \$38 million, there is a total of \$78 million that will be distributed throughout 20 jurisdictions to facilitate more efficient policies and protocols among victim service providers, laboratories, and police in testing and utilizing rape kits.

- New health regulations in the Affordable Care Act will now [protect](#) all genders under the proposed rule of Nondiscrimination in Health Programs and Activities. In particular this would extend protection to transgender people by granting them the right to use gender-appropriate restrooms and by prohibiting insurance companies from denying coverage based on discrimination.
